#### PURISHED HUMANIST LETTERS:

#### In this Country, We have Freedom of Religion

There were some unfortunate letters published Monday in your paper (St Pete Times) which spoke fervently against building a mosque near ground zero, and about prejudice suffered by other religions in Muslim countries.

My question to the writers of these letters, and to all the other "patriotic" citizens who feel this way, is: Exactly what does freedom of religion mean to you? This is one of the most basic rights guaranteed to all of us in the Constitution. It does not say, "Except when you're a Muslim." Do not forget that many Muslims lost their lives on 9/11 as well.

My understanding is that the property is owned by the Muslim group that wants to set up the mosque. It is their private property. Should we take that away too? This is a moderate Muslim group that has lived and worshipped here for many years, peacefully, and wants to build a community center. They are Americans. They are the kind of Muslims we should encourage and welcome.

I will not compare our Bill of Rights to freedoms offered to other religions in Dubai, Yemen, Egypt, or Iran. I am an American. I do not want to emulate their culture. I am grateful every day that I was born here, and that I understand my rights and those of other Americans, no matter what their religion (or lack of one) is.

# **Evolution Institute announces August 27 - 30 workshop at Duke,** 'Integrating Behavioral Economics with Evolutionary Theory'

There is widespread agreement that economic theory must become based on a more accurate conception of human nature to successfully guide public policy. That is the objective of behavioral economics, which has become prominent within the larger field of economics. However, behavioral economics needs to become more broadly based in the human behavioral sciences, which in turn must be grounded in evolutionary theory. The purpose of our project is to properly ground behavioral economics in evolutionary science, including the study of proximate mechanisms in a more fully rounded sense. We intend to provide the most accurate conception of human nature possible based on current scientific knowledge, oriented toward the formulation of economic theory and public policy. This objective, in turn, will require an integration of subfields within the human behavioral sciences, including evolutionary psychology, cognitive psychology, applied behavioral analysis, sociology, cultural anthropology, and neurobiology. These subfields need to be brought together before they can be related to an applied science such as behavioral economics.

This working group is one of three that emerged from the recent National Evolutionary Synthesis Center (NESCent) catalysis meeting titled "The Nature of Regulation: How Evolutionary Theory Can Inform the Regulation of Large-scale Human Social Interactions" which was organized in collaboration with the Evolution Institute. The EI has provided an organizational structure that includes a large community of interest (COI) in addition to the catalysis meeting participants. The working groups will take advantage of the same organizational structure, allowing the 10-12 people who work intensively on the project to interact with the other working groups and an engaged audience of scientists, economists, and policy makers across disciplines. HFA cofounded EI in 2008, when HFA president Jerry Lieberman and renowned author and scholar David Sloan Wilson planned the first workshop that fall at the University of Miami. ## **Humanists Decry Stem Cell Research Ruling**

Washington, DC, Aug. 24, 2010

An injunction by a federal judge has put federally funded stem cell research on hold, compromising the progress of vital medical breakthroughs, the American Humanist Association (AHA) said today. U.S. District Judge Royce C. Lamberth ruled on Monday that funding of stem cell research violates a federal ban on taxpayer dollars going towards the destruction of embryos.

"The ruling is a step backwards for science, a likely disruption to important research, and this will cause real harm to many in need of medical innovation," said David Niose, president of the American Humanist Association, who pointed out that the case was brought by a Christian adoption agency whose executive director is on record as seeking to impose a conservative Christian view on national stem cell policy. "The injunction appeases religious conservatives who seek to have their theological opinions define public policy. Thus, this is just another example of how the obstructionist agenda of the religious right has real social consequences."

### It's Time for the FDA to End the Overuse of Antibiotics on Farms

A human health crisis is brewing on our nation's farms. An estimated 70 percent of antibiotics used in the United States are fed to animals that are not sick, a practice that breeds antibiotic-resistant bacteria and causes costly, painful, and sometimes deadly human diseases.

Last year, the Food and Drug Administration (FDA) acknowledged the scientific consensus on the connection between human health and this nontherapeutic antibiotic use on the farm. Yet the FDA's actions, including a recently released set of principles on this subject, have done nothing to tackle the problem and miss the mark on the full scope of inappropriate antibiotic uses. The FDA has asked for public feedback on this issue. Write today to tell the agency to get serious about addressing antibiotic overuse in animal agriculture!

#### ON THE WAY TO GRAMMAR'S HOUSE

#### - Stray Thoughts

All of them open for adoption.

The supra-libertarian fantasy, "Atlas Shrugged," is on its way to film some 53 years after its publication (Shakespeare should have had it so good). Low-budget with a beginning director and unknown cast, it may well wind-up going direct to DVD or viral online distribution. At any rate it would be a kind of coitus completus for those still (or anew) under the spell of Ayn Rand and more people will have solved the bumper-sticker mystery of "Who is John Galt."



"Atlas Shrugged" never had me in its thrall, but I did fall prey to ""The Fountainhead" at an impressionable age (17 or 18) and took far too long to rid myself of its imprint, not so much on my political or vocational life, as on my personal one.

Bobby Valentine, the former big league baseball player and manager, now a commentator, is almost the spitting image of Ron Paul, but runs more to handsome than Paul who leans pun intended toward gaunt. Paul named his son "Rand," in case you missed the connection.

In a recent newsletter, Frank Prahl harked back to the days when it wasn't polite to talk about politics or religion in public. but he neglected to mention ""sex," which was also a banned conversational substance. They were kind of an unholy trinity. Well, we Suncoast Humanists have certainly overcome the embargo on talking politics and religion., but we seem to be either inhibited or uninterested in sex outside of reproductive and gay rights.

I've discovered and recommend a 2001 National Geographic picture-and-text book, available in the county library system (pals.polarislibrary.com), "I Dwell in Possibility: Women Build a Nation 1600-1920." The main title is from a poem by Emily Dickinson. It's lovely; no other word would fit better.

At our last Suncoast meeting I was challenged to define what I mean by "meaningful work," which I'd asserted would be a requirement for a good life in a society that makes a good life available to all. I can better explain after more thought. A basic definition is that it would be primarily work that you would be glad to do if you weren't paid for it, or work that may not be attractive in itself, but in undertaking it you would recognize that it is a necessary element to make life pleasant for all. However, a society organized in such a fashion would permit oversized financial compensation for such jobs [collecting garbage, digging ditches, cleaning toilets, drudge work] as opposed to today's oversized financial compensation for doing magic tricks on Wall Street or amusing us to death (as Neil Postman put it), encourage long or frequent vacations and otherwise ameliorate working conditions.

After the meeting, our topic being "Equality," I was offered in conversation the view that unemployment was far worse in countries, European in particular -- the "social democracies" -- that put more emphasis on equality, and through higher taxation are able to provide wider and more extensive employment benefits than we do in the U.S. In other words, excess unemployment is a penalty they have to pay for their largesse (despite tax rates that are punitive from a typical American point of view). My firm conviction, and retort, was that unemployment is no worse in those countries than it is here and in most cases better, but I had no specific statistics in mind or on hand. I'd like to supply them here, less for the specifics but to make a point about the exceptionalist, nationalistic rhetoric that suffuses our mass media and can brainwash even critical thinkers among us, especially when the foundation has been laid in K-12 education where wishful thinking about the American past is presented as historical fact (and I don't doubt for a minute that the same kind of exceptionalist early childhood indoctrination, adapted to their own particular themes, is the case in other countries).

[We interrupt this narrative for a brief joke. The claim that George Washington was the father of our country was attacked some years ago when it was revealed that the longtime Los Angeles Dodgers first baseman, Steve Garvey, recently traded to the San Diego Padres, was about to produce at the same time children with both his wife and a mistress and, as I best recall, was also being sued in some sexual context by a third woman. The speculation was that this outbreak of paternity would spread to other National League cities (there was as yet no interleague play) and Garvey was considered, prospectively, the new (and real, since Washington was genetically childless) "Father of Our Country."] Now, back to our regular programming.

First, for the month of June 2010 (last available) U.S. Bureau of Labor Statistics show unemployment rates, with foreign numbers converted to conform to U.S. measurement standards (all %s): Netherlands 3.4, Austria 3.9, Japan 4.8, Australia 5.6, Denmark and Greece 6.6, Canada 7.3, U.K. 7.7, Germany 7.8, Italy 7.9, Sweden 8.2, Finland 8.5, Belgium 8.6, France 9.1, UNITED STATES 9.3, European Union (27 countries including Eastern Europe) 9.6, Portugal 10.8, Ireland 13.3 and Spain 20.0. This is the complete list maintained by the BLS.

However, the World Fact Book via Wikipedia provides unemployment rates as of March 2010 for ALL 27 E.U. countries, but unadjusted to conform to U.S. standards, which adjustment seems with few exceptions to lower their rates by a half-point to a full point. Here they are (%s): Netherlands 4.1, Austria

4.9, Luxembourg 5.6, Slovenia 6.2, Cyprus 6.7, Malta 6.9, Germany 7.3, Denmark and Romania 7.6, Czech Republic 7.9, Belgium 8.1, U.K., Sweden and Bulgaria 8.7, Italy 8.8, Finland 9.0, Poland 9.1, European Union 9.6, UNITED STATES 9.7, France 10.1, Greece 10.2, Portugal 10.5, Hungary 11.0, Ireland 13.2, Slovakia 14.1, Estonia 15.5, Lithuania 15.8, Spain 19.1 and Latvia 22.2.

### **Humanists Praise Passage of Fair Sentencing Act**

Washington, DC, August 4, 2010

Leaders of the American Humanist Association (AHA) expressed approval of President Obama's signing the Fair Sentencing Act into law, significantly reducing the sentencing disparity between crack and powder cocaine.

"This corrects a historical injustice within our legal system," said Roy Speckhardt, executive director of the American Humanist Association. "The previous laws were racially biased and perpetuated the social and economic hardships already plaguing many disadvantaged members of our community."

The Fair Sentencing Act, which was signed into legislation by President Obama on Tuesday, is expected to diminish disproportionate racial divide within prisons, reduce prison over-population, and save millions in tax-payer dollars. The act will target high-level dealers and traffickers while limiting the excessive penalties for low-level crack offenders. The AHA supported the bill, lobbying members of Congress for their votes.



#### What is the FBI up to in your neighborhood?

Potentially, the agency is mapping your community by its racial and ethnic makeup and tracking ethnic-oriented businesses, behaviors and cultural traditions.

We intend to find out what they've been up to, and that's why the ACLU of Florida, along with thirty-two ACLU affiliates across the nation, submitted Freedom of Information Act (FOIA) requests this week. We are demanding information from FBI regional offices in Jacksonville, Miami and Tampa about what data they are collecting about communities and what they are doing with this information.

Demand accountability from your members of Congress about what the FBI is doing in your neighborhood.

We have real reasons to be concerned about race-based snooping in our communities. Internal FBI guidelines, called the Domestic Investigations and Operations Guide (DIOG), were published in December 2008 and made public a few months ago.

The DIOG claims to authorize FBI field offices to conduct "domain assessment" investigations in which **FBI agents can collect**, **analyze and** map racial and ethnic demographic information – including the location of ethnically-oriented businesses, particular racial and ethnic behaviors, cultural traditions, and lifestyle characteristics – in local communities.

Although some racial and ethnic data collection by some agencies might be helpful in lessening discrimination, the FBI's attempt to collect and map demographic data using race-based criteria to target entire communities for criminal enforcement and domestic intelligence purposes is inconsistent with American values and raises serious civil liberties concerns.

That's why we need your help. In addition to the ACLU's FOIA requests, we're calling on members of Congress. <u>Ask your members of Congress to find out what the FBI is doing in your neighborhood.</u>

The public deserves to know about a race-based law enforcement program with such troubling implications for civil rights and civil liberties. Please <u>take action</u> today.
