## **Humanists Celebrate Free Speech Victory in Arkansas**



(Washington D.C., August 12, 2011) Leadership at the American Humanist Association celebrated after a federal judge ruled in favor of the United Coalition of Reason (UnitedCoR), who had been denied advertising space for an ad reading, "Are you good without God? Millions are." The Appignani Humanist Legal Center filed a lawsuit on behalf UnitedCoR in response to the Central Arkansas Transit Authority's refusal to lease advertising space on its buses on account of the proposed ad's atheist and humanist content, violating the Free Speech Clause of the First Amendment.

"This is a victory for secular Americans everywhere, and proof that we will not be silenced," said David Niose, president of the American Humanist Association. "Humanists and atheists will indeed convey their message through the mass media, and they will fight through the courts if any discriminatory institutions try to stop them."

"The judge agreed that the transit authority likely would be found at trial to have violated the UnitedCoR's First Amendment right to free speech by discriminating against its atheist and humanist viewpoint, and therefore agreed to issue an injunction requiring the authority to contract with UnitedCoR on the same basis as any other advertiser," said Bill Burgess, attorney and legal coordinator of the American Humanist Association's legal arm, the Appignani Humanist Legal Center. "This is an important victory not only for the free speech rights of nontheists but for any American whose speech in a public forum may encounter government disapproval."

The decision is a testament to the movement's growing strength. In 2005, the American Humanist Association launched the first major secular advertising campaign, and the idea quickly caught on across the country as well as abroad. Similarly, the secular community had to rely on outside nonprofit groups for legal representation when humanist rights were violated, until the formation of the Appignani Humanist Legal Center in 2006, allowing humanists to spearhead efforts in federal court to protect the rights of nontheist Americans to advertise in Little Rock.

"Just a few years ago America had never seen a major secular advertising campaign or a humanist group capable of defending the rights of humanists in the courts," continued Niose. "In this case we see both, and it shows how far the movement has come in such a short time."

The Appignani Humanist Legal Center, a project of the American Humanist Association, provides legal assistance to defend the constitutional rights of secular Americans by challenging violations of the separation of church and state guaranteed by the Establishment Clause and seeking equal rights for humanists, atheists and other freethinkers.

The American Humanist Association (<u>www.americanhumanist.org</u>) advocates for the rights and viewpoints of humanists. Founded in 1941 and headquartered in Washington, D.C., its work is extended through more than 100 local chapters and affiliates across America. Humanism is the idea that you can be good without a belief in God.

The **United Coalition of Reason** is a nonprofit national organization that helps local nontheistic groups work together to achieve higher visibility, gain more members, and have a greater impact in their local areas. We achieve this goal by assisting local groups in the "community of reason" to cooperate with each other.

("Community of reason" is a generic term that includes all self-identified nontheistic organizations, whether they call themselves atheist, agnostic, bright, Ethical Culture, freethought, humanist, Pastafarian, rationalist, realist, skeptic, secularist, Unitarian Universalist, or whatever else.)

*Humanism* takes this one step further. As a 3000 year old philosophy rooted in the philosophical traditions of the west, Humanism has informed much of the body of secular writing in literature, poetry, philosophy, and the arts.

In contemporary terms, while organized humanism takes on the legal, political, and social rights of Humanists and other non-believers, a strong current is involved with advocacy for the beneficent outcome for the human creature as our species continues its evolution in the modern world. While the intense questions of Human survival that surround today's crises occupy the attention of many humanists, they are part of this same ancient tradition and provoke the same empathetic and compassionate responses that were the hallmark of humanist thinking during all the cataclysms of our history. Humanists would like to promote an unblinkered look at the totality and reach of the questions and propositions that arise from a conscious consideration of our present political, social, economic, and natural environment.. And always, there is never a fully complete answer to the question, "What does it truly mean to be human?" We must discover it for ourselves.

for jury duty seriously, but enough people skip out on their civic duty that a new and ominous kind of fraud has surfaced.

The caller claims to be a jury duty coordinator. If you protest that you never received a summons for jury duty, the Scammer asks you for your Social Security number and date of birth so he or she can verify the information and cancel the arrest warrant. Give out any of this information and bingo; your identity was just stolen.

The fraud has been reported so far in 11 states, including Oklahoma, Illinois, and Colorado, AZ and more. This (swindle) is particularly insidious because they use intimidation over the phone to try to bully people into giving information by pretending they are with the court system. The FBI and the federal court system have issued nationwide alerts on their web sites, warning consumers about the fraud.

## A Florida Freethought Victory

A benefit concert on Aug. 28 for EllenBeth Wachs, the embattled church/state separation activist with Atheists of Florida, turned into a celebration as she announced to her audience that the trumped up criminal charges against her had been dismissed: Prosecutors realized that it was not in their best interest to move forward to trial and offered a settlement agreement that dismissed the felonies and averted convictions on all charges.

According to the AF news release, "The arrests were meant as part of a retaliatory strategy by Polk County Sheriff Grady Judd to suppress her activism in church/state separation matters, which she had directed at his transfer of jail basketball goals to area churches. Judd, an outspoken evangelical Christian who has stated that he is on a 'mission from god,' keeps a Bible prominently displayed on his sheriff's office desk.

"EllenBeth stated, 'Mr. Judd's despicable actions against me shined a bright spotlight on the intolerance and bigotry that atheists face every day. The secular community around the world came out in force to support me and speak out against this persecution. His abuse of power angered and mobilized the atheist movement to action reminiscent of an earlier civil rights era."

She is president of the Humanists of Florida Association, as well as the legal affairs coordinator and vice-president for Atheists of Florida. EllenBeth recently wrote, "Now that this is over I can get a lot more focused. ... [I]t is a big relief to be a "free" woman!"

In the meantime, AoF President John Keifer, who was also placed in legal jeopardy for exercising his rights, needs financial assistance to fight back against this same abuse of power. Please help him by donating to the AoF Legal Fund: www.atheistsofflorida.org
