Two Brilliant lights of Tampa Bay Freethought are extinguished.



Rob Byrch, President of the Tampa Humanist Association and long time member and board member of the Humanist Society died on August 1st. He had gone to Tampa General Hospital for removal of an intestinal cyst, and was in the recovery room when he suffered a fatal heart attack.

He had been confidently optimistic about THC and his own future, and was looking forward to being free of the pain he had endured through much of the preceding year. Robert was a kind, generous, sensitive, and highly intelligent man who embodied a great many of the qualities that distinguish the life of someone who lives as a Humanist. Above all, he was a great and good friend.

Bill Hall, a longtime Senior Instructional Specialist at the Clearwater Campus, was found dead at age 49 on Tuesday, Aug. 7. Hall, who began working at St. Petersburg Junior College in 1988 as a part-time Instructional Assistant in the Learning Support Center, became a full-time employee in 1990 teaching writing and reading labs. An alumnus of SPJC, Hall was a finalist for the college's prestigious Apollo Award in 1989.

For members of the freethought community, his clever and apparently magical illusions always invited a perplexed smile. He was fascinated by the endless ways our human perception is vulnerable to illusions and tricks. He knew this was a facet of ourselves that invoked the creativity of our imaginations, while making us the gullible creatures we often are. He spoke often for the benefit of many freethought groups around the bay area and beyond.

"He was excellent instructor and tutor," said Matt Bowen, Associate Provost at the Clearwater Campus who worked in the LSC with Hall for 18 years. "He was a master at teaching students to think critically." Students often would drop by the LSC to talk with him and play with the puzzle and mind-teaser games he kept around his desk. "He was very beloved by students," Bowen said, describing Hall as an intellectual and philosopher with a great sense of humor. Hall received a bachelor's degree in philosophy from the University of South Florida in 1992. He completed additional graduate course work in reading and philosophy. Funeral services are pending.





Too often, at political conventions, free speech takes a beating.

Political parties intent on keeping the focus on their carefully managed messages do everything they can to make sure protesters don't steal the show. And local authorities let legitimate concerns about security be used to mask totally illegitimate efforts to stifle and silence dissent.

In the next two weeks, tens of thousands of protesters will descend on Tampa where the Republicans are meeting. We have to make sure their First Amendment rights are fully protected.

Working with police and protesters alike to help safeguard free speech, the ACLU is already on the ground in Tampa and Charlotte, where we are:

- Hosting public forums — live and online — educating hundreds of people about their First Amendment rights.
- Distributing "know your rights" materials in advance and during the conventions.
- And will have staff on the ground to monitor police activity at protests during the conventions.


At a recent board meeting, we made plans to participate with an **information table** at a major public event in the coming year.





We, the people of the State of Florida by our delegates in Convention assembled, in the city of Tallahassee, on the 25th day of October, in the year of our Lord 1865, and of the Independence of the United States, the 90th year, in order

Amendment 8

The amendment will require taxpayers to fund houses of worship without their knowledge, and will give religious organizations an unfettered right to receive state funding. So, even the most extreme or repugnant groups who say they are religious would essentially have an unrestricted constitutional right to taxpayer dollars. This would be both offensive and potentially reckless public policy.

The measure is misleading. The real goal of Amendment 8 is to give the Legislature the power to promote taxpayer-financed school vouchers that would require Floridians to subsidize private religious schools. There should be an up or down vote on vouchers and an end to pretending this is about religious freedom.



NOW is a multi-issue political organization. NOW's self-defined role has been to initiate change for the benefit of the greatest number of people, to affect the legal and institutional structures of the society in a way that systematically expands the choices and possibilities available to all women. In this way, NOW takes action to bring women, as a class, into the mainstream of society, rather than offering aid to individual women in achieving personal solutions or temporary relief from oppression.

The Florida National Organization for Women (NOW) is in strong opposition to the Personhood Amendment ballot initiative for which the organization Personhood Florida is currently collecting signatures, according to Florida NOW president Donna Slutiak. "This amendment is ridiculous and an insult to women," Slutiak said. "The issue of Personhood would have very far reaching results, and would do more than criminalize abortion; it would also make birth control pills and the IUD illegal in the state of Florida. The amendment states that human life begins at the time when an egg is fertilized, which will also impact in-vitro-fertilization clinics. How would you like your mother's fertilized eggs that are sitting in a clinic freezer to have inheritance rights?"

Do you want to have to go underground to get your birth control pills?" Florida NOW expects all intelligent people to pledge not to sign this initiative, and to vote against it, if by some fluke it does get on the ballot. Personhood is bad for womanhood."

Topic: Mormonism

You may know that Mitt Romney is a Mormon, but do you know what Mormons believe? Are you familiar with their religious rituals and their dietary restrictions? What about Mormon views on social issues like homosexuality, abortion, and racial equality? In this interactive presentation, Ryan T. Cragun, drawing upon his recently published book addressing these topics, will clearly explain some of the many beliefs and practices of Mormonism that make the religion so unique.

Ryan T. Cragun is an assistant professor of sociology at the University of Tampa. His research focuses on the nonreligious and Mormonism. His research has been published in a variety of peer-reviewed journals, including: Journal for the Scientific Study of Religion, Sociology of Religion, Nova Religion, Journal of Contemporary Religion, and Journal of Religion and Health. He is also the author of several books and book chapters and has had several essays published in Free Inquiry. When he isn't working, he can typically be found spending time with his son and wife, hiking, cooking, or watching science fiction.

After the untimely death of our leader, **Rob Byrch**, the board of directors has set about the task of reorganizing the association, and continuing the programs, finding new leadership, and keeping the flame lit which Rob ignited for the benefit of the people of Tampa.

For several years now, various leaders of the freethought community in the bay area have been meeting informally to share experiences, and occasionally to coordinate plans. But recently, changing circumstances have brought additional pressure to cooperate in bringing programs and members services to an expanding movement.

At this point leaders continue to meet, and together with the various boards of directors and committees, try to develop policies that will enable every group to enhance its unique role in serving its members.

There appears to be general agreement on developing several community wide programs over the year that will allow significant speakers to be presented in our area. The costs of these programs will be shared among the organizations proportionally.

Thus substantive and exciting new activities will be offered to the Tampa Bay area that were not possible for most organizations before. We are especially grateful to the national office of the United Coalition of Reason and its director, Fred Edwards. You may recall that UCoR was the major impetus to getting a large number of billboards erected across the nation with such messages as "You can be good without God. Millions are!"

TBCoR is an alliance of groups identified with the freethought / Humanist /Atheist movement.

As this momentum continues to grow, we will keep you informed of developments. JP

Our stressful future

We can redesign our economic, political, transport, health care, and food systems to be less brittle and more resilient. Suggestions along those lines have been on the table for years and have been largely rejected because they don't serve the interests of powerful groups that benefit from the status quo. Meanwhile the American populace seems incapable of raising an alarm or responding to it, consisting as it does of a large under-class that is over-fed but under-nourished, over-entertained but misinformed, over-indebted and under-skilled; and a much smaller over-class that lives primarily by financial predation and is happy to tune out any evidence of the dire impacts of its activities.

But what is becoming increasingly evident is that our essential systems that sustain the vital center of our society and economy are undergoing severe stress. Physical infrastructure, natural renewable resources, and industrial materials are under pressure by a needful and growing population of humans who, on a planetary level, aspire to live the lives revealed and promoted by the mass media. At this same time, the climatic system, water sources, and the productiveness of an exhausted soil, call into question our ability to provide even the essentials.

We humans are clever and adaptable, and with our unique talents and abilities, we can forgo the temptations of magical thinking, national and religious imperatives, rampant consumerism, and other diversions from the necessary tasks ahead.

A way must be found to bring the necessary unity to our common purpose which has no less a goal than human survival.

Those who maintain a conscious awareness of the problems of our society are a minority of people among the overwhelming numbers of the manipulated masses on whom enormous resources are dedicated to maintaining compliance with the institutions of the status quo. What should have been, and what may yet be, a saving technology - the internet, that allows users to acquire and use the information needed to liberate themselves from the oppressive acquisitiveness that pervades so much of life has been a disappointment. But some way must be found to allow people to reach this potential if humanity is to survive the excesses of its own follies. Perhaps there is another way.... JP





The festivities kick off with a Tap Takeover party on Tuesday, July 31st at Funky Buddha Lounge, located at 776 Lincoln Street. They will be tapping award winning craft beer from Tampa, Florida's Cigar City Brewing—an establishment that is well known by craft beer enthusiasts. The pre-screening schedule also includes a freethought celebrity Texas Hold 'em poker tournament and casino night charity event on Wednesday, August 1st. Aptly dubbed "Poker in the Church", it is being held at 1160 Lincoln Street at The Church nightclub. Adding to a long history of supporting equal rights for women, the **American Humanist Association Board of Directors** unanimously passed a resolution calling for passage of the Equal Rights Amendment (ERA). The ERA was originally introduced in 1923, and passed by Congress in 1972. Thirty-five states have ratified the Amendment, three short of the 38 states necessary for adoption.

"There is no reason to wait any longer for women's equality," said Roy Speckhardt, executive director of the American Humanist Association. "Discrimination on the basis of sex continues to this day, and the swift passage of the Equal Rights Amendment will finally provide the protection women deserve."



"Until the Equal Rights Amendment is adopted, women will continue to be treated as second-class citizens, legally, because without protection under the Constitution, our fundamental rights are subject to the whims of local lawmakers and our recourse is limited," said Zelda Gatuskin, co-chair of the Feminist Caucus of the American Humanist Association. "This is long overdue. Congress needs to step up and commit to the ideal of equal justice for all."

The American Humanist Association is supporting the Three-State Strategy, a legal position that holds there is no time limit for the remaining states to ratify the ERA because none is mentioned in the text of the amendment itself, only in its proposing clause.

The American Humanist Association (AHA) first supported the Equal Rights Amendment by issuing a resolution in 1975, and again in 1982. The AHA also adopted a resolution on Equal Pay for Women in 1963 and the World Bill of Rights for Women in 1981. The Feminist Caucus of the American Humanist Association was established in 1977 as a coalition of women and men working toward the advancement of women's rights and equality between the sexes in all aspects of society.



Fighting Cracks in the Wall

The following statement authored by the Coalition Against Religious Discrimination earlier this year supports the first Amendment.

The undersigned religious, education, civil rights, labor, and women's organizations write to voice our opposition to the language of the Adams Amendment (Amendment #1) to H.R. 4970, the Violence Against Women Reauthorization Act of 2012. We oppose the Adams Amendment insofar as it would alter the nondiscrimination clause in the base bill to remove protections that bar federally funded religious discrimination. **We urge you to Vote NO on the Adams Amendment**, as government funds should not be used to underwrite employment discrimination within government-funded projects and activities.

We appreciate the important role religiously affiliated institutions historically have played in addressing many of our nation's most pressing social needs, as a complement to government-funded programs. Indeed, many of us are directly involved in this work. We also recognize that the separation of church and state is the linchpin of religious freedom. In our view, effective government collaboration with faith-based groups does not require the sanctioning of federally funded religious discrimination.

In accordance with Title VII of the Civil Rights Act of 1964, religious organizations may prefer co-religionists in hiring when using their own private funds. The Adams Amendment, however, would permit religious organizations to take VAWA funds and use those funds to discriminate against a qualified individual based on nothing more than his or her religious beliefs. VAWA should protect against taxpayer dollars being used to underwrite jobs where religion is a factor in hiring decisions.

Adopting the language in the Adams Amendment would be inconsistent with the longstanding principle that federal dollars must not be used to discriminate. Accordingly, **we urge you to vote No.**

Remove "In God We Trust" from our currency and remove "under God" from the Pledge.

Having God on our currency and in our Pledge of Allegiance fuels the false belief that the United States is a Christian nation. As declared in the Treaty of Tripoli, 1796, "...the Government of the United States of America is not, in any sense, founded on the Christian religion." This was signed by president John Adams. Having God in our currency and in our Pledge of Allegiance directly disrespects those among us who are not of the Christian, or of any faith, and it should be removed.

Humanism and Politics

It would be difficult to reconcile an embrace of humanism with opposition to, for example, contraception, same-sex marriage, cohabitation without marriage, laws and regulations that protect and promote racial and gender equality, freedom of expression, and universal suffrage. If we truly respect individual autonomy, we must allow individuals the freedom to give shape and direction to their own lives, especially with respect to critical, life-altering choices, such as whether and whom to marry and whether or not to bear children. We also must ensure that individuals have the opportunity to pursue a livelihood without restrictions based on characteristics such as race or sex. It is also important that every adult have the right to participate in political life and have a role in deciding who our legislators and chief executive should be.

There are also issues on which most humanists agree and with respect to which there is at least a strong presumption in favor of a certain position. Legal-ization of physician assistance in dying for the terminally ill, aka physician-assisted suicide, is one such issue. Certainly, a humanist cannot oppose legalization based on a quasi-religious notion such as the sanctity of life. However, I have known humanists who oppose legalization based on speculation about the harms that might follow legalization, such as pressure on patients to request assistance in dying or a decline in the quality of health care for those with terminal illnesses. The evidence from Oregon and Washington (the two states where assistance in dying is currently legal) indicates that these concerns are probably unwarranted, but it would not be irrational for a humanist to oppose legalization as the evidence cannot be said to preclude completely the possibility of significant harm.

Effectively, that is the key to determining whether a policy position—call it position A—is consistent with humanism: Is position A supported by evidence-based reasoning? To be more precise: Is there an argument supported by some plausible set of facts and sound, secular, evidence-based reasoning that position A will cause less harm than position B, and is position A as respectful of fundamental freedoms and individual autonomy as possible? As humanists may disagree about the facts relevant to resolution of a particular issue, *Continued on Page 13*

it's not only possible but inevitable that there will be a number of issues on which humanists differ.

This brings me back to my initial question about the consistency of being a humanist and being a Republican. In answering this question, it must be admitted that in recent decades the Republican Party has been heavily influenced by the religious Right and has adopted policies antithetical to humanism. If we limited our examination of Republican Party positions to its stance on certain key social issues and the extent to which government can support religious institutions, then we might be tempted to conclude that there is a severe tension between being a Republican and being a humanist.

However, the Republican Party's position on social issues, such as abortion and same-sex marriage, represent only a fraction of the entire Republican Party platform. The 2012 platform was not completed and approved as of the time of this writing, but a review of the 2008 Republican platform (available online at www.gop.com/2008Platform/2008platform.pdf) reveals that only about five of its fifty-five pages were devoted to policies on "Pre-serving Our Values." The rest of the platform dealt with national defense, foreign policy, the budget process, fiscal policy, entitlement funding, taxation, government regulation, energy policy, immigration, health care, and about a dozen other issues, including relatively narrow questions such as governance in U.S. territories.

Because humanists place great weight on individual autonomy, it is not surprising that there is a tendency to focus on policies that restrict our ability to make our own decisions about children and marriage and seek to impose religious dogma on us. We don't like theocrats in our bedrooms. But precisely how much weight one should give to these social issues is not something addressed by humanism. Some humanists might view policies relating to national defense, entitlement funding, and taxation as being relatively more important than policies relating to same-sex marriage or the availability of contraception. It would not be irrational to come to such a conclusion. In other words, one *can* be a humanist and a Republican—although presumably a Republican not altogether pleased with the party's stance on some significant social issues.

I have spent some time on this question because, in my discussions with individuals about the work of the Council and the Center for Inquiry, it is not infrequently assumed—especially during a presidential election year—that humanists constitute a subset of the Democratic Party. As a factual matter, most humanists probably do support Democratic candidates more often than not. But humanism does not compel them to do so. When we say that CFI and the Council for Secular Humanism are nonpartisan organizations, we do not make that assertion solely to placate the Internal Revenue Service. We really mean it. Humanism is a life stance, but it does not come accompanied by a detailed platform specifying positions on all the issues that a national political party is expected to address.

That's not to say humanism is devoid of public policy implications. To the contrary, both the Council, through the Secular Coalition for America, and CFI, through its own lobbying arm, the Office of Public Policy, have advocated vigorously (and sometimes effectively) for certain specific policies. In doing so, we believe that we have adopted positions that reflect humanist principles and with which most of our supporters would agree. We regard this advocacy work as an important part of our mission, and we also regard the issues that engage us to be important. How these issues ultimately affect an individual humanist's vote, however, is something for that individual to determine. Humanism has no party line.

* * *

Let me turn briefly from domestic politics to a question of **international human rights**. Again this year, the Center for Inquiry and its affiliates will be commemorating **International Blasphemy Rights Day (IBRD)** on September 30. When CFI and its affiliates first started to commemorate IBRD in 2009, some tried to trivialize this effort, suggesting that it was worse than pointless (and some of this criticism came from so-called humanists!). Actually, it was very important to call attention to the continuing suppression of speech critical of religion. Events in the last several months have underscored that, if anything, this problem is worse than it was three years ago. In Pakistan, one can lose one's life by merely suggesting that its blasphemy laws should be reformed, and both Saudi Arabia and Kuwait have reacted harshly to "tweets" that were alleged to have defamed "the Prophet." In Indonesia, a so-called "moderate" Muslim country, Alex-ander Aan was attacked and beaten by a mob and then placed under arrest on a charge of blasphemy after he declared he was an atheist on Facebook. (The outcome of his trial is not known at this time.) And just a couple of days before I started to write this editorial, it was announced that a new book by Muslim author and activist Irshad Manji was banned in Malaysia for being blasphemous and for causing "disturbance to the public."

Some CFI branches will be holding events to commemorate

IBRD (look for e-mail alerts). In addition, we expect to meet with State Department officials this summer to discuss problems relating to international religious freedom.

What can you do? First, if you are not already “out” as an atheist or agnostic, there’s no better time to do it than on IBRD. You may have heard: in most Western countries, it’s no longer a crime to be an atheist. Sure, you may risk some ostracism, but if people in other countries are willing to risk jail or death to make an honest statement about their beliefs, you can risk a cold shoulder from a neighbor.

Second, keep informed about the persecution of people like Aan. If his case is still pending, or if he has been convicted and sentenced, contact the Asian Human Rights Commission or some other responsible body to protest the government’s action. (See CFI’s previous news announcement on his case: http://www.centerforinquiry.net/news/urgent_add_your_voice_to_support_jailed_atheist_in_indonesia/.) People everywhere should have the right to express their views about any religious belief. That’s what IBRD is all about.

We have been instrumental in examining and reporting upon the Tarpon Springs “weeping icon,” hypnosis, (in)famous psychics, local astrologers, etc.

TBS does not reject claims out of hand, but rather is committed to objective and critical inquiry. In this vein, we share the philosophy of the Committee for Skeptical Inquiry (CSI) -- publisher of *Skeptical Inquirer* magazine, an international organization that has nurtured the growth of local skeptics groups (such as ours) all over the world.

Death from a Humanist perspective

Our community has lost some great thinkers and great men recently and I wanted to write something about the Humanist approach to death and grief as it seems particularly relevant.

Humanism is an optimistic philosophy. We see no point in facing life's adversities pessimistically. We are also very realistic about death. We know we are going to die. And actually, we find this thought strangely very motivating. Our thinking is thus: If we are going to die, we might as well make the best of it while we are here. And that means, not succumbing to pessimism. We Humanists believe we can make things better, if we just try. And when we can't, we might as well laugh about our predicament.

When someone we love and care about dies, we don't try to hide from our grief. We accept that the person is dead and that we will never see them again even though we may want to. Yes, it hurts, but it is better than avoiding grief by pretending that even though our loved one is dead they aren't really dead. All that does is prolong our grief.

I was recently asked to officiate at a funeral of a Humanist who was not part of our community. He may not have known we even existed. I am not a trained celebrant but the family was desperate to have a funeral that honored their father and did not provide them with the false hope of religion. Like most people who lack faith, this family did not want to be told their father was in a better place. He wasn't anywhere anymore. He was dead.

If you have never been to a Humanist memorial service, let me just say they are unlike a religious service. Because Humanists are non-religious, and therefore don't believe in heaven or hell, there is no need to help the deceased get into heaven. And, even if there is a heaven or hell, it is highly unlikely that a memorial service will have an impact on the routing of the deceased anyway, so the focus is on helping the living.

Humanist memorials are quite moving, specifically because they are designed for the living. A humanist memorial service helps the survivors come to terms with the death of their friend and/or loved one. By remembering their life you celebrate their life, and the impact they had on yours. You have an opportunity to say goodbye (an opportunity you may not have had otherwise.) In short, these services help the living come to terms with their loss.

Because I was officiating at this funeral, I missed the memorial meeting for Robert Byrch, a man I was glad to call my friend. The

funeral was really rather emotional for me because as I was helping this family come to terms with the death of their father, I was coming to terms with the death of my friend.

On the drive home I cried quite a bit. But I know that Robert would have been very upset with me had I not helped these people. And that is because Robert was a Humanist. He was committed to being a good person and helping others. The best way I could honor his friendship was to help a complete stranger with their grief.

This incident alerted me to a problem our community has. We don't have enough celebrants. This poor family spent 5 days trying to find a Humanist to conduct a ceremony and only found me (who isn't a celebrant) the night before the funeral. No family should have to go through what they went through while they are grieving. There is no nobler calling than helping someone who truly need your help as people who are grieving do. The funeral director told me he gets requests all the time from people looking for non-religious funerals. So let's collectively step up and offer to help. Become a celebrant.
