#### The 2019 Florida Legislative

**Session** is under way, and unfortunately, numerous bills have been filed that pose grave threats to our civil rights and civil liberties.



Currently, numerous bills threaten: a woman's right to access abortion care, to worsen racial disparities in our criminal justice system, exacerbate the school to prison pipeline, enable racial and ethnic profiling of people of color and immigrants' across the state.

Other bills, those with less chance of passage, would contribute positively to life in Florida: by eliminating driver's License suspensions for non-driving related offenses, acting on HIV Prevention, removing employment barriers for people with past convictions.

#### Your Best Letters...

As a first generation American whose father and all grandparents were born in Eastern Europe, I listened with more interest than most, to the sentencing of Paul Manafort.

My grandfather came here just after WWI, and worked four years to save enough to bring his family here in 1921. Although my family was lucky to escape most of the horrors of domination by Russia, their friends and other relatives were not.

When I was a child, and through young adulthood, we received many letters from them about their treatment by the occupying Russian soldiers, who would enter their homes at any time, sleep in their beds when they wanted, filthy boots and all, take any food that appealed to them, and generally treat them like servants. There were so many examples of their cruelty, and I listened to the letters as my parents read them.

That is what Paul Manafort was attempting to do to Ukrainians while he made millions of dollars lobbying for pro-Russian politicians in that country.

It was unbelievable to me when Judge Ellis said, "'He's lived an otherwise blameless life" and "has no criminal history" when he sentenced him to a relatively short term. I feel cheated not only by the millions in taxes Manafort did not pay, that people like me had to make up, but also for the years he should have spent in custody for trying to place the Russian yoke onto the people of Ukraine for nothing other than greed and reluctance to give up his high-flying life-style!

How could a judge have so little awareness or consideration of his horrible behavior? He had no compassion in his lobbying efforts, but was sure to ask for (and seems to have received) compassion from Judge Ellis. Shame!!

Why do Florida Legislators hate public education? Senate Bill 7070 establishes the "Family Empowerment Scholarships" which would use taxpayer funds to support private, sectarian schools. The bill only provides scholarships for up to 15,000 students, out of the 2,587,197 total students enrolled in public schools. But there is nothing to prevent them from continuing to expand that number yearly until everyone qualifies. The flagrant disregard by legislators for the Florida Constitution is also disconcerting.

Article 1, Section 3, states "No revenue of the state or any political subdivision or agency thereof shall ever be taken from the public treasury directly or indirectly in aid of any church, sect, or religious denomination or in aid of any sectarian institution." By allowing taxpayer funds to go to sectarian schools not only does it reduce the support of the public schools, it clearly violates the constitution.

In my opinion, part of the goal of public schools is to prepare students to live in a democracy, to value cooperation, fairness, and justice. This can only be achieved by having to interact with people who have different values and viewpoints. That is why public schools are so important. People meet others they might never encounter in the world in which their family resides such as church, country club, street, etc. Civics education has never been more important. We must learn how to live together, work with people of divergent views, and protect everyone's rights.

#### **Failed Economics**

By Rex Weyler, PCI At the end of 2018, Credit Suisse published its updated report on global wealth. Forty-two-million millionaires and billionaires comprise the richest 0.5% of the world's population. That translates to 0.8% of adults in the report, possessing 44.8% of the world's economic wealth. A decade ago, researchers commonly reported that the wealthy 15% of humanity owned 85% of the resources. Today, 6.2% (9.5% of adults) now claim 85% of the wealth. The rich got richer.

The super-elites, the 2,208 billionaires — those who attend Global Economic Summits, own banks, buy off governments, pollute with impunity, and hold political influence in virtually every nation in the world — comprise not the "1%" but only 28-millionths of a percent of the human population. According to Forbes magazine, the average billionaire makes about \$635 million dollars every year, \$12 million per week, even when they're on holiday.

For these people, neo-classical economic theory works just fine, but only if one ignores the human and ecological costs: poverty, squalor, homelessness, migrations, biodiversity loss, global heating, disappearing forests, toxic land and water, and rising, acidic oceans. Capitalism is designed to benefit those who have capital, the wealthy. For most of humanity, modern neo-classical economics erodes well being. For the ecosystem at large, neo-classical economics serves as a rationalization for plunder.

#### A Prize for Ecological Ignorance

Last year, international economists awarded their colleague, William Nordhaus, the "Nobel Memorial Prize in Economics." This is not a genuine Nobel prize, but rather an award sponsored by Sveriges Riksbank "in Memory of Alfred Nobel."

In the 1970s and 80s, Nordhaus played a key role in dismissing the now-confirmed, "Limits to Growth" study. In a 1991 paper, "To slow or not to slow," Nordhaus argued that although economic

growth increases carbon emissions, nations should not sacrifice growth to combat climate change. He discouraged carbon emissions reduction because, in his estimation, global heating just doesn't hurt the world's economy that much. "Don't let anyone distract you from the work at hand," Nordhaus told his students, upon winning the prize, "which is economic growth."

Climate scientists and ecologists have blamed Nordhaus for rationalizing the failure of governments to take urgent climate action. Some fellow economists — Nicholas Stern at the London School of Economics; Martin Weitzman, at the US National Bureau of Economic Research; and others — have disputed Nordhaus' assumptions, calculations, and conclusions. In February, at the Scottish Economics Conference in Glasgow, Steve Keen, Head of the Economics, History and Politics School at Kingston University in London, explained errors and omissions in Nordhaus' theories, which lead to what Keen calls his "absurd" conclusions about climate action.

Nordhaus and other economists choose, arbitrarily, to discount the future. If we valued future generations equally to ourselves, we would assume a discount rate of zero. Nordhaus prefers to discount the future at 6% annually, which presumes that communities twelve years from now have less than half the value of a community today. A community or individual 70 years from now has only 1% of our value. The high discount rate allows Nordhaus and colleagues to argue that the economic cost of reducing emissions today is too high compared to the "low" benefit of protecting people in the future. No wonder the youth are in rebellion!

At the Center for Inquiry, we believe that evidence-based reasoning, in which humans work together to address common concerns, is critical for modern world civilization. Moreover, unlike many other institutions, we maintain that scientific methods and reasoning should be utilized in examining the claims of both pseudoscience and religion. We reject mysticism and blind faith. No topic should be placed off limits to scrutiny—certainly not fringe science and religion, which have an enormous influence on beliefs and conduct.

We also maintain that values are properly the subject of study and discussion as much as empirical claims. The Center for Inquiry studies and promotes human values based on a naturalistic outlook. Ideological doctrine and religious dogma have no more right to dictate our moral norms than they do to influence scientific research.

The Center for Inquiry supports research, but our mission activities go far beyond sound scholarship. The Center for Inquiry, and its affiliates, the Committee for Skeptical Inquiry and the Council for Secular Humanism, also carry out their work through education, publishing, advocacy, and social services. The Center for Inquiry has established dozens of regional centers and communities, which provide a means of delivering educational programs and services on a local level and provide a venue for like-minded individuals to meet and share experiences. In addition, the Center for Inquiry has affiliates and sponsors programs in many different countries. A secular society ultimately should embrace all of humanity, not just selected countries.

In aiming to foster a secular society, we do not seek to abridge the rights of believers. We vigorously object to government support of religion and the use of religious dogma to justify public policy; we do not oppose the free exercise of religion. The secular society we are building is a community of reason and compassion in which the dignity and fundamental rights of all individuals are respected.

Fostering a secular society requires attention to many specific goals, but three goals in particular represent the focus of our activities:

- O- An end to the influence that religion and pseudoscience have on public policy
- ♦- An end to the privileged position that religion and pseudoscience continue to enjoy in many societies
- ♦- An end to the stigma attached to being a nonbeliever, whether the nonbeliever describes her/himself as an atheist, agnostic, humanist, freethinker or skeptic.

And however prettily they dress up the outside, it's vital that we look below the surface to determine whether their gift is in reality full of soldiers seeking to sack Troy or just a giant turd between two delightful slices of fresh sourdough bread.

How things are presented matters. But what is underneath that presentation is also critical, and very often we see charming presentation used as an attempt to sneak terrible content through. The opponents of legalized and safe abortion are masters of this technique. For years they have spoken of "Partial Birth Abortions," choosing that language to demonize a rare and medically necessary procedure, Intact Dilation & Extraction.

There's one comment from a law school professor of mine that has stayed with me vividly. When any student would mention "states' rights," he would launch on an irritated tirade. "States don't have rights. Individuals have rights. Rights are things the state can't do to you. States have powers." And he was right. The term "states' rights" was used to because rights are a good thing. Bad governments take away rights. And thereby, it could gloss over what "states' rights" actually meant in the real world – the justification of viewing human beings as property and, later, the treatment of people, based solely on their race, as second-class citizens.

We are seeing the same use of presentation by our opponents now. The same attempt to dress up abusive and appalling policies in the language of rights and freedoms. It's essential that we keep that in mind when we look at the world. When we campaign to remove exemptions from mandatory vaccination laws, as our media guru Paul Fidalgo spent yesterday in Maine doing, our opponents cry out for their "parental rights." This is, of course, nonsense. There is no right to expose your child, or all the other children they will come in contact with at school, at the mall, or in the park, to potentially fatal, debilitating diseases unnecessarily, based solely on the ramblings of a fourth-rate actress online, and the self-serving, faked experiments of a struck-off doctor.

But the error here goes so much further than this. The entire notion of "parental rights" here is a flawed one that seeks to mask the reality – the abuse of children through their needless exposure to danger – in the language of freedom and rights. Let's be clear on this. Being a parent does not give you rights. The rights that are talked of here are the rights of the child. It is the child that has the right to choose whether to be vaccinated and, thereby, likely protected from a whole range of diseases that have been the scourge of humanity, or not to be vaccinated and to roll the dice with their own safety.

Of course, in the overwhelming majority of cases, we recognize that children are not positioned to exercise their rights and make these choices. We therefore allow parents to act as a guardian of those rights and exercise them on behalf of the child. This is a very good thing. The parent is, in most situations, the one best placed to make such decisions. When deciding whether a child should study German or French, play football or swim, watch American Idol or go to bed at 8 pm, we default to the parents. Having government decide this would be not only impractical, it would also represent a form of tyranny that is incompatible with a free society. But that's not saying the parents have the "right" to require those things of the child. Instead, the parents are exercising their best judgment in the service of their children. They are

the caretaker of the child's rights until that child is sufficiently developed to exercise them on their own behalf.

There have always been situations where we as a society have recognized parents are not the best placed to exercise the rights of the child. Regardless of parental wishes, children must be educated, may not work in coal mines, and cannot purchase alcohol or cigarettes. The child's right to safety and education is paramount there. The parent not only does not have the right to send their child to work at the textile mill, they are not seen as the correct guardian of the child's right to choose where (and when) to work.

Unfortunately, where we allow these rights of the child to be overridden, it is far too often in the name of a similar misnomer, the "religious freedom" of the parent. The Supreme Court, in *Yoder v Wisconsin*, 406 U.S. 205 (1972), allowed Amish parents to withdraw their children from school after the 8th grade. While laws regularly require lifesaving medical intervention against parents' wishes, Idaho still exempts harm caused by parental reliance on faith-healing from child abuse laws. Parents are free to send their children to schools which deny them a scientific education, replacing it instead with religious dogma.

Where our opponents present their claims as defending "religious freedom" or "parental rights," it is essential we look deeper. Who really owns the rights at issue? Children are not property. Their parents do not own them and do not own their rights. While it is good that we grant parents a broad range of discretion in how they exercise their children's rights, the basic point must not be forgotten. They are the child's rights, not the parent's. No amount of linguistic games change that. Justifying vaccination exemptions as "parental rights" or "religious freedom" doesn't alter what they are – stealth attempts to deny the right to a healthy future to our children.

The FDA announces in a press release that it's **none too pleased** with Nutra Pharma Corp. a company that makes homeopathic products for the treatment of chronic pain and addiction. Outgoing FDA commissioner Scott Gottlieb says:

Health fraud scams like these are inexcusable. These patients deserve proven treatments not false promises that can deter them from seeking otherwise effective care, and that can also contain ingredients or contaminations that can threaten their health.

Elizabeth Cohen and John Bonifield at CNN report on the ferocity and vileness of anti-vaxxers' attacks on anyone who dares to advocate for vaccinations, even if that someone is a parent who just lost their child to the flu:

Nothing is considered too cruel. Just days after their children died, mothers say anti-vaxers on social media called them whores, the c-word and baby killers. ...

Some anti-vaxers told [grieving mother Jill Promoli] she'd murdered [2-year-old] Jude and made up a story about the flu to cover up her crime. Others said vaccines had killed her son. Some called her the c-word.

The worst ones — the ones that would sometimes make her cry — were the posts that said she was advocating for flu shots so that other children would die from the shots and their parents would be miserable like she was.

Read the whole piece, because it gets much worse. For example:

"I hope they stone you to death," another Facebook user wrote. "I'll make a special trip to happily watch your head crack. The parents of the children you are destroying should each get a chance. Like a nazi piñata."

Canada's *Waterloo Region Record* worries that there's not enough being done to **counter anti-vaxxers' propaganda**:

...what makes the situation more frightening and surely more dangerous for the entire public is that more and more parents are turning to utterly useless but readily available homeopathic remedies.

No, no no. These parents are wrong if they think they're protecting their daughters and sons by giving them products such as homeopathic "nosodes" instead of having them inoculated with safe, effective government-approved vaccines.

Italian far-right politician Massimiliano Fedriga is an outspoken opponent of mandated vaccinations, calling them "Stalinist." **He's been hospitalized with chicken pox**. He's doing fine, and doesn't appreciate your schadenfreude.

Voice of San Diego reports that there is one single doctor, Dr. Tara Zandvliet, who is responsible for authorizing almost one-third of all the San Diego school district's medical exemptions to vaccinations. Zandvliet, however, is not anti-vax (she says), but seems to just have a much lower threshold for exemptions, including a family history of allergic reactions.

West Virginia's attorney general has **filed a novel suit** against the state's Catholic diocese: consumer fraud. NYT reports:

The West Virginia approach alleges that the diocese and bishop "knowingly employed pedophiles" at Catholic schools and camps but did not disclose to parents the "danger" of sending their children to these programs, which advertised safe environments. The suit also says that church officials did not conduct adequate background checks for employees of Catholic schools and camps.


"We believe that every parent who paid tuition for a service that falls under consumer protection laws deserves to know the schools their children are attending are safe," the West Virginia attorney general Patrick Morrisey said in a phone interview. "The church itself advertised that these children would be in a safe environment."





Legislation that allows or encourages the intrusion of religion into government or citizens personal lives, bills that give tax payer dollars directly to religious institutions, and bills that prevent/minimize religious intrusion. #### Here are just some of the problematic bills...

#### Bills that allow religious intrusion:

Requiring each school to offer an elective course on the study of the bible and religion (HB 195)

Educational standards that require teaching of controversial subjects in a "balanced" manner (SB 330).

And at least two bills that would restrict a woman's reproductive health choices (SB 558, SB 792 and HB 235).

#### Bills that give money directly to religious institutions:

Two bills that provide funding for security at Jewish Day Schools (HB 2105 and HB 2277).

A bill to provide funding of a church expansion (because their membership has grown) (HB 2771).

A church wants funds to offer an alternative event for Halloween (HB 2137).

A church wants money to fix their parking lot (HB 3865).

#### And finally, a few bills that would minimize intrusion:

A bill that brings Florida into compliance with marriage equality (SB 254 and HB 6009)

Prohibits conversion therapy for children (SB 84 and HB 109); Requires public schools to teach sex education based on science (SB 926 and HB 703).

#### Walking Away From the Left

His name is Brandon Straka. He is of male gender and Caucasian pigmentation, so in this day and age his WalkAway campaign is, of course, probably unworthy of even the slightest attention. On the other hand, he is young. And gay. And (until very recently) a lifelong liberal Democrat. So even if that does not compel acceptance of his every word (in light of the Jussie Smollett fiasco), maybe his story is deserving of at least a token listen.

I don't think you will ever find Straka being interviewed, or even discussed with disgust (other than being dismissed as a Russian-supported propagandist), on CNN or MSNBC. Or ABC, CBS, or NBC. You could try randomly wading through a myriad of his YouTube videos. I happened to stumble upon him the night of March 3rd while channel surfing and stopping on the dreaded Fox News Channel in the midst of this discussion with attorney Mark Levin (tinyurl.com/Levin-Straka).

I stopped to watch because at first glance it looked to me like Levin was interviewing David Copperfield — the resemblance is uncanny. But rather than seeing someone who employs elaborate apparatus to create stunning illusions, Straka appeared to be deconstructing one — the most all-consuming one on the political landscape — with mere words. He discussed the litany of the left's indictments against "the world's biggest bigot" (Donald Trump) and, thanks to his trusted news sources, how "scared to death" he had been upon the President's election. "I really believed everything that the liberal media told me." That is, until his first inkling that the atmosphere inside the progressive bubble might contain an insalubrious smog of smoke and mirrors. That sudden insight precipitated

the strangest experience I've ever had in my life. I almost ... dissociated for a moment because there was this disconnect between my brain and my heart, because my brain was telling me, "Oh my god, I don't think [Trump really did what they said he did]." My heart was saying, "But we hate him, but we hate him, but we hate him." ... And so I couldn't reconcile within myself what had happened. ... [W]hy did CNN tell me that he did, because CNN has never lied to me before? So why did they start lying today?

Perhaps the ingredients in Straka's servings are as tainted as at Chez Jussie. If so, Straka should be shut down just as quickly. But whereas everything in Smollett's kitchen was obviously fishy from the outset, the items on Straka's menu, while alien to those with a progressive palate, may actually pass a preliminary smell test.

If you watch the first two minutes of that show and your vital signs remain stable, it's probably safe to watch another couple. And if you persevere to the 12-minute mark, you will hear him explain how "Once you see it, you can never unsee it. Once you realize what they're doing, you see it every single time." At that point, if your appetite isn't sufficiently whetted for the next course, you can certainly just ask for the check.

But since you'll probably be dining here only this once, what's the harm of hanging around and sampling the full assortment? The worst that can happen, if his story elements appear to flow coherently and his reasoning seems sound, is a brain/heart "disconnect" similar to Straka's. And as long as you make sure that your friends and family never find out ... Well, maybe it's not really worth the risk after all.

## Evolution, illustrated: Study captures one of the clearest pictures yet of evolution in vertebrates

January 31, 2019, Harvard University

What do you get when you put together several tons of steel plates, hundreds of mice, a few evolutionary and molecular biologists and a tiny Nebraska town near the South Dakota border? One of the most complete pictures ever of vertebrate evolution?

Led by Professor of Organismic and Evolutionary Biology and Molecular and Cellular Biology Hopi Hoekstra, a team of international researchers conducted a years-long study in which hundreds of **mice** were released into massive, custom-built outdoor enclosures to track how light- and dark-colored mice survived in light- and dark-colored habitats.

The results not only confirmed the intuition that light-colored mice survive better in light-colored habitats, and vice versa for dark-colored mice, but also allowed researchers to pinpoint a mutation related to survival, specifically that affects pigmentation, and understand exactly how the mutation produced a novel coat color. The study is described in a February 1 paper published in *Science*.

"This project has been many years in the making, and part of the inspiration for it came from the experimental evolution studies people have been doing for many years now using microbes in the lab," Hoekstra said. "The idea has been that you start with a particular population, genotype it, and then give it environmental challenges and watch how the population evolves over generations. Then you genotype it at the end and you can see, at the genetic level, what changes.

"We were interested in replicating that approach but doing it in vertebrates, and doing it in a natural environment," she continued. "And letting them evolve in habitats that—importantly—are open to predators, or at least visually hunting, avian predators."

To do it, then postdoctoral fellow Rowan Barrett (now a faculty at McGill University) and colleagues traveled to the tiny town of Valentine, Nebraska in order to take advantage of an important natural habitat—the Sand Hills.

As early as the 1930s, Hoekstra said, it had been observed that mice living in the sand hills—a large area of contiguous sand dunes with sandy, light-colored soil—are lighter in color than those living in the surrounding areas with dark, loamy soil.

Ultimately, though, Hoekstra said the study offers an important—and importantly complete—picture of how evolution works in mammals.



"What I like about this study is it starts at the organismal level and goes all the way down to a mutation, and understanding how, precisely, that mutation leads to a change in phenotype and how that change leads to survival differences in the wild," she said. Furthermore, neo-classical economic theory discounts the poor, since they don't add much to economic growth. For example, Nordhaus dismisses the global heating threat to agriculture, forestry, and fishing because these enterprises contribute only about 4% of global GDP. Should food production decline, starvation in poor nations will hardly impact global GDP. Furthermore, these economists discount the entire biosphere — insects, birds, whales, forests, rivers, and dying coral reefs. The thousands of species that go extinct each year due to human activity don't matter since they were not, allegedly, adding anything to human economics or well-being. This suite of discounts bolsters the Nordhaus argument that slowing carbon emissions is not important.

In a 1992 paper, Nordhaus feigned to take the 1972 Limits to Growth study seriously, while shrewdly mocking the study, referring to its acceptance by the "popular imagination" and by "the anti-growth school ... of pessimism," wherein people "fretted" over trivialities such as "climates overheated by greenhouse gases." Meanwhile, he implied that sophisticated economists, such as himself, understood that "an efficiently managed economy need not fear ... resource exhaustion," nuclear meltdowns, or global heating.

By insisting on linear, simplified economic models, dismissing biophysical limits as trivial, status quo economists ignore the way dynamic living systems actually function. Biological growth in living ecological system necessarily encounters complex interactions, resource depletion, population limits, waste recycling, feedbacks, and system-changing tipping points. All of this remains virtually absent in Nordhaus and most of modern economics.

## Evidence Based Solutions in the workplace

Anyone involved in HR and Diversity Issues knows - what we are doing isn't really working. We still have bias. We still have discrimination. We still have problems with inclusion. And none of the initiatives seem to make a dent. Some do, it specific cases, but as a problem plaguing society and our workplace, it's pretty sticky.



This is why I want to share the Evidence Based D&I HR Magazine article.

We need to use more science to help us solve these problems. One of the ways we try to solve D&I problems is by compiling reports about experiences of black, Asian, minority and ethnic people in organizations to ask about their experiences. And these stories are useful to help us understand the impact of the dynamics and experiences that people are having in an organization.

What this doesn't do is help us come up with solutions to fix them. It is simply not enough to tell stories to try and get people to care. There are other sciences we can bring in to help us. Like, behavioral science, or sociology or psychology.

Another thing that won't work is "solutioneering" which I refer to as proxy problems. Where people decide that the problem is we have not instituted a particular solution. When that might not be the problem at all.

One of these "solutions" is unconscious bias training. But the evidence is that this training doesn't actually change behavior. There are several reasons why that is the case - one of which is what I teach - the science of how behaviors actually change.

The advice they give is please don't just act so you can be seen to be doing something. Do something that will actually work. This requires decision makes to be conscientious, explicit and judicious in seeking out and using evidence to design your intervention.

#### The Green New Deal - Explained

When the Intergovernmental Panel on Climate Change (IPCC) published their latest report in October, the message was stark: if the planet wants to avert dangerous climate breakdown,we need to cut emissions in half by 2030, and hit net zero by the middle of the century.

It would be difficult to overstate how dramatic this trajectory is. It represents a total and rapid reversal of our present direction as a civilization. We've built up a global energy infrastructure around fossil fuels over 200 years, and now we need to completely transform it in 30.

The only way to accomplish this feat is with coordinated government action on a massive scale. Proponents of the US's Green New Deal idea have it right: we need to pump public investment into churning out solar panels, wind turbines and batteries at a historically unprecedented rate, reminiscent of the industrial retooling that enabled the allies to win the second world war.

But even this won't be enough, in and of itself. There's something missing from the Green New Deal strategy – and it could turn out to be a fatal flaw.

The problem with the existing plan is that it doesn't address the paradox of growing energy demand. Over the past few years, scientists have been warning that we may fail to reach our climate goals even with the most aggressive efforts, because global economic growth is driving energy demand up at a pace that's outstripping our ability to install clean power.

Today the world is producing 8bn more megawatt hours of clean energy each year than in 2000. That's a lot – enough to power all of Russia. But over exactly the same period, economic growth has caused energy demand to increase by a staggering 48bn megawatt hours. In other words, all that new clean energy we've rolled out covers only a small fraction of new demand. That's why emissions keep rising. It's like shoveling sand into a hole that just keeps getting bigger.

This problem is going to eventually cripple us. If we continue growing the global economy at existing rates, it will nearly triple in size by the middle of the century. That's three times more production and consumption than we're already doing – which will require nearly three times more energy. It will be difficult enough for us to decarbonize the existing global economy – virtually impossible do it three times over.

Our obsession with economic growth is making our task much more difficult than it needs to be. It's like we've chosen to fight this battle facing uphill, with one hand tied behind our back.

There's an easier way. The recent IPCC report points out that to have a realistic chance at staying under 1.5C, we need to scale down energy demand. The scenario its proposes – developed by an international team of scientists – calls for high-income nations like Britain and the US to significantly reduce their consumption of material stuff.

Right now, rich nations devour 28 tonnes of material per person per year – including everything from fish to forests, plastics to metals. That's four times more than ecologists say is sustainable. It requires an extraordinary amount of energy to extract, produce and transport all that stuff. By using less of it, we can shrink global energy demand and make it much easier to decarbonize the economy.

This isn't just about convincing individuals to lead simpler lives, although of course we need that. It's about changing the way our economy operates – liberating ourselves from the irrational imperative to grow material use unnecessarily.

How can we do this? One way is to legislate extended warranties on products, so washing machines and refrigerators last for 30 years instead of 10. Another is to ban planned obsolescence, so manufacturers can't create products that are designed to fail. And we could introduce a "right to repair" so we can get our smartphones and blenders fixed cheaply when they break down rather than having to buy new ones.

We could also cut down on waste by banning food from landfill (as South Korea and France are doing). We could tax red meat to promote a shift to less resource-intensive foods, and ban single-use plastics and disposable coffee cups. We could liberate public spaces from advertising (like São Paulo has done) to free us from the psychological pressures of having to buy stuff just to feel good about ourselves. And we can expand access to public goods and develop platforms for sharing things like cars and lawnmowers.

All of these measures would dramatically reduce material consumption, without any loss to our wellbeing. But to really make it work, we need to get straight to the heart of the issue: put a cap on annual material use and tighten it year on year, down to 8 tons per capita by the middle of the century. This will change incentives across the economy – reorienting people and business toward long-lasting, repairable and recyclable products.

By dramatically reducing energy demand, this approach will give us a good shot at accomplishing our climate goals.


What's exciting about this is that it doesn't just help us avert climate breakdown. It also provides our best hope of reversing other aspects of ecological collapse – from deforestation to soil depletion, from biodiversity loss to insect die-off. Reducing our material impact on the Earth means freeing up more space for other living systems to recover and thrive.

We need to do everything we can to transition to clean energy, yes. But we'll only succeed if we reduce the amount of energy we consume in the first place, rather than continuing to grow it. The science is clear: scaling down material use must be at the core of the Green New Deal – and at the center of our climate policy.
